#### **Members Absent:**

#### 1. Call to Order and Pledge of Allegiance

The Chairman, Commissioner Carlton Henley, called the meeting to order at 10:38 a.m. Chairman Henley asked Commissioner Arrington to lead the Pledge of Allegiance.

#### 2. Approval of Minutes

**Motion** was made and seconded to approve the Minutes of the December 11, 2008 Board of Directors meeting. The motion passed unanimously.

#### 3. Recognitions

The Chairman recognized Edward Johnson, Chief of Staff, to recognize LYNX employees for their years of service.

#### 4. Public Comments

Joanne Cormelis addressed the Board and discouraged cutting services. She encouraged providing 24 hour service 7 days a week including holidays and weekends.

Cheryl Stone addressed the Board regarding the Transportation Disadvantaged Trust Fund. She thanked the Board and Staff for their support of the Fund's preservation during the recent Legislative Special Session.

#### 5. Chief Executive Officer's Report

The Chairman recognized Linda Watson, Chief Executive Officer, to report on the following items:

1. Staff just completed their preliminary reports for the December 2008 ridership. The numbers indicate that ridership for the month was down approximately 12%. Within the month of December, service was reduced approximately 3%. Previously, LYNX has been able to sustain its ridership; however, the year end service changes appear to have had an impact. In January 2007 the fares were increased by approximately 17% and in January 2008 the fares were increased by approximately 14%. The January 2008 fare increase could not have impacted December's ridership. LYNX ridership could continue to decline. Other factors that could have impacted ridership are the increased unemployment in the core service area of over 7% and the 19% decrease in gas prices over the past several months.

Mayor Crotty reported that the Orange County Expressway Authority has reported that ridership is down 10%. The Tourist Development Council reported that last month's reductions were 13%, and the Greater Orlando Aviation authority reported the passenger count was down 13%. The Mayor noted that the Expressway Authority had completed some extensive research regarding the decline and offered to share the information with LYNX. He said the reports indicate that unemployment and the economy had a greater impact than gas prices.

2. At the recent meeting of the Transportation Research Board Executive Committee, three of the five members of the Presidential Transition Team for Transportation spoke on transportation in the future. Their role in the DOT transition was to evaluate programs and policies and provide policy recommendations to the in-coming DOT Secretary. They began their work prior to Labor Day by interviewing all upper level DOT employees in all transportation modes and interviewing over 100 outside agencies, experts and stakeholders. At the conclusion of their work, they found three common themes that kept coming up: 1) climate change, 2) energy, and 3) transportation. They will recommend to the Secretary that all three be linked by policy and that transportation become part of the solution, not the problem. They will also recommend that: DOT take a stronger policy role in transportation and invest and build infrastructure. The Team urged the represented organizations to be prepared by mid-February to early March for the distribution of stimulus dollars. The money will need to be used quickly to meet the goals of job creation and preservation.

3. The stimulus program is now known as the "American Recovery and Reinvestment Bill of 2009." To date, only the House Democrats have put forward a plan which totals \$825 billion which includes \$550 billion in spending and \$275 billion in tax breaks. The plan allows for the funds to flow through existing federal agencies to the states and local governments through existing formulas. Highlights of the list of spending proposals include: \$30 billion for highway spending and \$10 billion for transit and railroad projects. Under the formula programs, \$6 billion is appropriated for the Transit Capital Assistance Program and for Fixed Guideway Infrastructure Investment; \$2 billion is appropriated for rail modernization projects. Under these programs, the FTA must apportion the funds within 7 days of the bill's enactment. Recipients will be required to spend no less than 50 percent of the funds within 120 days of enactment with the remaining 50 percent spent within 2 years. The funds have a 100 percent federal share with no local match required. Estimates for specific amounts for states and urbanized areas are being developed.

There will likely be many changes in the bill as it goes through the House and Senate but the process has started. Once the bill is passed, attention will turn to the federal agencies that administer the provisions.

#### 7. Action Agenda

The Chairman announced that a Blue Sheet Action Agenda Item has been added to the Agenda and will be taken up in place of Action Agenda Item 7.A.

# A. Blue Sheet Item: Authorization for the Chief Executive Officer (CEO) to Enter Into a Lease Agreement with Congressman Alan Grayson for Office Space in LYNX Central Station

The Chairman recognized Edward Johnson, Chief Administrative Officer, for presentation.

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to negotiate and subsequently execute a lease with Congressman Alan Grayson (Congressman) as the tenant for the remaining space on the fourth floor of the LCS (which is not currently occupied by the Clerk of the Orange County Circuit Court). The Lease will be for a period of two years. LYNX remains in negotiations with the Congressman over the terms of the Lease although a rough draft of the Lease that has been prepared on behalf of LYNX has been provided to the Board. The authorization requested from the Board is to permit staff to continue to negotiate with the Congressman and assuming that there is no material change in the terms of the Lease, then for the CEO to be authorized to execute the Lease on behalf of LYNX without further Board approval.

Pat Christiansen, LYNX General Counsel, noted that during the process of leasing office space within LCS, the FTA has an interest in the process as a result of the monies it provided to initially build the facility for its originally intended use as a transportation center. FTA has been provided information regarding the lease arrangements in order to obtain their approval. The Lease with the Congressman has the same provision as the Lease with the Clerk of the Orange County Circuit Court for LYNX to have the ability to recapture space for LYNX' purposes.

**Motion** was made and seconded to authorize entering into a Lease Agreement with Congressman Alan Grayson for Office Space in LYNX Central Station. The Motion passed unanimously.

## B. Authorization to Enter into the Revised FY2008-2009 Service Funding Agreement with the City of Kissimmee

The Chairman recognized Bert Francis, Chief Financial officer, for presentation.

The City of Kissimmee has indicated that their FY2009 funding will be reduced from \$220,000 to \$120,000 this year, resulting in an additional \$100,000 funding requirement from Osceola County or may result in reduction of services. In accordance with LYNX' funding practices with other counties, any funding shortfalls from the cities revert back to the related county.

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to enter into the FY2009 Funding Agreement with the City of Kissimmee, a regional funding partner, in the amount of \$120,000 for local financial assistance.

**Motion** was made and seconded to authorize entering into the revised FY2008-2009 Service Funding agreement with the City of Kissimmee. The Motion passed unanimously.

The Chairman announced that a Blue Sheet Action Agenda Item has been added to the Agenda and will be taken up as Action Agenda Item 7.C.

### C. Blue Sheet Item: Authorization to Approve the Proposed Workers' Compensation Settlement for Mary Cope

The Chairman recognized Bert Francis, Chief Financial officer, for presentation.

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to approve the proposed Workers' Compensation settlement for Mary Cope. The settlement is to be paid over a three (3) year period beginning in February 2009.

**Motion** was made and seconded to approve the proposed workers' compensation settlement for Mary Cope. The Motion passed unanimously.

#### 8. Work Session

#### A. Update on the FTA Follow-up Procurement Review

The Chairman recognized Bert Francis, Chief Financial officer, for presentation.

The Federal Transit Administration (FTA) contracted with Calyptus Consulting Group, Inc. to perform a follow-up review of the Procurement System used by LYNX in the expenditure of grant funds. The Procurement System Review (PSR) process uses a standardized approach, interview guides, checklists, and reporting framework. This process was applied to the review of LYNX in an abbreviated format because it was a follow-up to the 2006 procurement review, and only those procurement system elements deficient during that review were assessed.

The review covered procurement actions from April 1, 2007 to June 30, 2008 and found sixteen elements deficient. The reviewing Contractor made seven recommendations to improve LYNX' procurement system such as utilizing FTA forms and templates and matrix of contract clauses. A number of the review findings were addressed with the Board's approval of the Administrative Rules 4 and 5 on today's agenda as well as continued staff training on FTA requirements.

After the submission of the revised Administrative Rules and their implementation, the FTA will visit with LYNX for two days. During their visit, they will assist with additional training, if necessary, to ensure the corrective measures are in place and being monitored.

#### **ACTION REQUESTED:**

Staff is requesting LYNX Board of Directors' authorization for the Chief Executive Officer (CE0) or designee to issue a Request for Proposal (RFP) for the printing of bus passes in an amount not-to-exceed \$110,000. The term of the contract will be for three (3) years.

#### **BACKGROUND:**

Over the last six (6) or more years, LYNX has purchased its bus passes from Electronic Data Magnetics, Incorporated (EDM) out of Winston-Salem, North Carolina. In conjunction with the implementation of LYNX' new farebox in 2002, LYNX purchased new passes with a magnetic stripe. The magnetic stripe allowed customers to swipe bus passes with various validation periods versus flash passes with fixed periods based on the calendar months. At that time, LYNX converted the monthly and weekly passes to 30-day and 7-day passes. This allowed passengers to get the full benefit of the pass.

EDM has provided LYNX with a pricing structure consistent with their contract with Hillsborough Area Regional Transit Authority (HART) in Tampa, Florida. Although, the pricing with EDM appears to be reasonable, we need to confirm this with the current market to ensure that we are paying the most competitive price. This will be confirmed through the RFP process.

#### **FISCAL IMPACT:**

LYNX has included \$110,000 in the FY2009 operating budget to support the printing of bus passes.

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to award a contract to AppleOne Employment Services, CareersUSA and Top Talent Staffing. The contract term shall be for three (3) years. The subject contracts are at an annual "Not to Exceed" cost of \$85,000 in the aggregate per contract year.

#### **BACKGROUND:**

LYNX utilizes between five to ten temporary employees per year primarily in the areas of administration, clerical, human resources, accounting and finance. Temporary employees also assist with the annual physical inventory count of fixed assets conducted in the fourth quarter of each year. By utilizing temporary employees, LYNX is afforded the flexibility of managing staffing levels within the organization. In addition, key tasks can still be completed with little or no interruption of day-to-day business while LYNX looks for the right talent to fill open positions.

At the October 11, 2008 LYNX Board of Directors meeting, staff received authorization to release a Request for Proposal (RFP) for temporary staffing services. The proposal was released on November 12, 2008 and proposals were due to LYNX by 2:00 PM EST on Monday, December 29, 2008.

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to award a contract to Doug Bloodworth Enterprises, Inc. The initial contract term shall be for four (4) years. The subject contract will have a "Not to Exceed" cost of \$600,000.

#### **BACKGROUND:**

At the December 11, 2008 LYNX Board of Directors meeting, staff received authorization to release a Request for Proposal (RFP) for the painting of buses. It is necessary that this contractor be able to realistically reproduce artwork on all LYNX vehicles (LYNX buses and other LYNX vehicles such as cars, carts, trucks and vans). The artwork must be completed in a timely manner - one-sided bus within 3 calendar days and two-sided bus within 5 calendar days.

Under Florida Statue 287.057, procurements involving artistic services are not subject to competitive solicitation requirements.

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to exercise the second option year for Workers' Compensation and Tort and Public Liability Third Party Administrative (TPA) Services with Integrated Claim Solutions, Inc. for the period of March 1, 2009 through February 28, 2010.

#### **BACKGROUND:**

The award of Contract 05-001 was approved by the Board of Directors on January 27, 2005. The Contract was awarded for an initial period of three (3) years with two (2) one (1) year options. The initial contract period started on March 1, 2005 and expired on February 29, 2008. The first option year was authorized by the Board on February 26, 2008. This is the second option year.



The contract includes services provided by the TPA as follows:

#### **Workers' Compensation Third Party Administrative Services:**

The TPA provides professional services for the handling of the Workers' Compensation claims filed with LYNX, as necessary, in conjunction with the LYNX Risk Management Division. The TPA is responsible for all filings with the State, updating the States new Electronic Data Information (EDI) system, determining compensability and all payments, if necessary, and attending all hearings and all court proceedings.

#### **Tort and Public Liability Third Party Administrative Services:**

The TPA provides professional services for the handling of the Tort and General Liability claims that are filed with LYNX, as necessary, in conjunction with the LYNX Risk Management Division. The TPA is responsible for investigating and assessing all claims for liability, issuance of any payments that are due, negotiations for settlements and obtaining all releases and scene investigations as necessary.

#### **FISCAL IMPACT:**

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to release an Invitation for Bid (IFB) to award a fixed price contract for the construction of the Osceola Square Mall Bus Pullout Facility. It is anticipated that this facility will service up to 4 different routes and future service in the Osceola County service area.

#### **BACKGROUND:**

The Osceola Square Mall is located at the intersection of US 192 and Armstrong Road within the city limits of Kissimmee. For a number of years, this facility has served as a significant transfer point for 7 routes that serve, originate and terminate in Osceola County (LINKS 4, 10, 18, 26, 55, 56 and 57). The most current data indicates that this facility currently serves at least 2,350 passengers per day. As such, it is second only to LYNX Central Station in terms of passenger boardings per day.

The construction of this facility is seen as a complement to the larger Transfer Center being proposed for construction in downtown Kissimmee. The LYNX Transit Development Plan (TDP) identifies the Osceola Square Mall location to continue serving as a transfer point for existing and future proposed LYNX services including, potential feeder flex bus service similar to what currently operates in Poinciana.

For at least the past 15 years, LYNX has been making transfers in the Osceola Square Mall parking lot (not streetside). While this has been advantageous to LYNX from a capital



perspective, the current facility is not conducive to our customers or our rolling stock. From a customer perspective, a single shelter that seats approximately 6 is the only amenity provided. With respect to our rolling stock, the parking lot is black top pavement. As such, it does not withstand the impact of LYNX buses over time, resulting in necessary repairs every 3 to 4 years at a cost of \$8,000 to \$10,000.

Based on this information, LYNX has been negotiating with the Mall ownership and management over the last fiscal year to develop a more palatable solution. LYNX and the Mall have in concert established a need for a four bus pullout bay that will be located street side on Armstrong Road. The facility will also have two large 15' x 15' shelters that will seat at least 16 people per shelter in addition to 3 wave benches for additional seating. The facility is also designed to have 2 additional shelters installed as demand and budget availability warrants. LYNX and the Mall are currently negotiating a transit license agreement for the portion of the project that will be located on Mall property. In addition, LYNX is currently in permitting review with the City of Kissimmee for this project.

Once engineering is complete and the project has received final site plan approval by the City of Kissimmee, LYNX will issue an invitation for bid (IFB) to award a fixed price service contract to construct the bus pullout bay. It is anticipated that the project will be permitted and ready for construction by March 2009. The anticipated release date is early March. The contractor will have sixty (60) calendar days to complete the project after the Notice to Proceed has been issued.

#### DISADVANTAGE BUSINESS ENTERPRISE (DBE) PARTICIPATION:

LYNX procurement policies require prime contractors to use their best efforts to subcontract a portion of their work to DBE firms. However, each DBE goal will be determined with the development of each scope of work.

#### **FISCAL IMPACT:**

This project is 100% Federal Transit Administration grant funded and is included in the Board adopted FY 2009 amended Capital Budget.

The grant application will request \$1,000,000 in funding for capital project costs eligible under the Federal Transit Administration Section 5311 Nonurbanized Area Formula program such as preventive maintenance and the capital cost of contracting. Funds made available under the ARRA are available at 100% Federal share.

#### **BACKGROUND:**

The Florida Department of Transportation (FDOT) is asking for a very quick turnaround on requests for ARRA funds from its 5311 partners in order to expedite capital projects as intended by the Act. As the designated recipient of FTA funds for rural areas, FDOT is soliciting applications for capital projects for rural areas. FDOT will ensure inclusion of the project activities in the TIP/STIP and the Work Program.



LYNX currently provides services between Orlando and the rural communities of Bithlo, Zellwood, Sanford, Oviedo, Kissimmee, St. Cloud, and other rural portions of Orange, Osceola, and Seminole counties. The Federal rural capital assistance of approximately \$1,000,000 will be used for preventive maintenance costs associated with the provision of rural transportation services, as well as the capital cost of contracting services.

The FY 2010 Section 5311 funds will be programmed by FDOT and the JPA will be executed in FY 2009.

Attached is the Authorizing Resolution #09-001 for the FDOT grant applications.

#### **FISCAL IMPACT:**

It is estimated that approximately \$1,000,000 of Federal funds (at 100% Federal share) for rural capital may be available in FY 2009. Grant funds will be obligated in FY 2009 under a Joint Participation Agreement with FDOT.

The Functional Assessment evaluates an ADA applicant's physical and cognitive ability to access our fixed route bus system. The Travel Training promotes independence and allows those applicants who can access the fixed route bus service to be trained to do so. For every trip that we are able to transition from our ADA paratransit program to our fixed route bus service, LYNX recognizes a savings of approximately \$35.

#### **FINANCIAL IMPACT**

There is no fiscal impact to the FY2009 budget, as the Functional Assessment and Travel Training is currently budgeted at \$185,711 annually. The award of the contract will be during Fiscal Year 2010, and the expected pricing should be below \$200,000 and will budget as such.

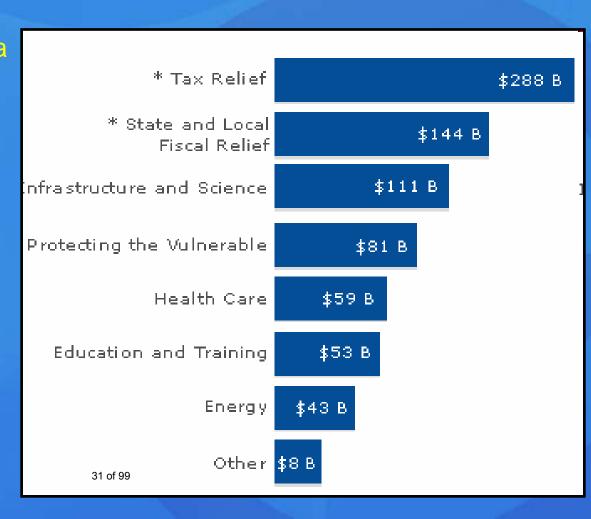

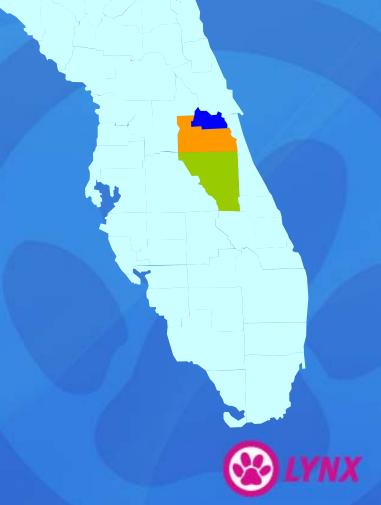

Authorization to Enter into a Revised FY2008-2009 Service Funding

**Agreement with Osceola County** 

Date: 2/26/2009

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to enter into the FY2009 funding agreement with Osceola County, a regional funding partner, in the amount of \$5,075,993 for local financial assistance.

#### **BACKGROUND:**

In September 2008, the LYNX Board of Directors approved a funding request in the amount of \$4,975,993, which is a 5.3% increase over the FY2008 funding amount. However, the Osceola Board of County Commissioners approved a funding amount of \$4,867,305, which is a 3% increase over the FY2008 funding. This represents a discrepancy in approved funding amounts of \$108,688.

In addition, the City of Kissimmee has reduced their FY2009 funding from \$220,000 to \$120,000 this year, resulting in an additional \$100,000 shortfall in funding from Osceola County. In accordance with LYNX' funding practices with other counties, any funding shortfalls from the cities revert back to the related county. That leaves the County with a \$208,628 shortfall. Additionally, Osceola County has asked us for options and costs for reinstating some type of service in an area where service was discontinued tin December based on efficiencies and route restructuring.



The County has also asked LYNX to consider further operating efficiencies by reducing the "deadhead" mileage from routes serving the county. Deadhead miles are miles traveled by revenue vehicles when not carrying passengers in revenue service, i.e., miles traveled to and from the garage at the beginning and end of the route. Because the LYNX service area is 2500 square miles, there can be significant deadhead miles in some areas.

Accordingly, staff is working with the County to determine if there is an "interim" and/or permanent location for a satellite operating facility or other approach for reducing deadhead miles in order to bring the costs of the service down. In the meantime, it was agreed that Osceola County will make monthly payments to LYNX based on the amount of funding in their FY09 budget until the matter is resolved. The agreement will be based on payments by Osceola County that are consistent with the amounts budgeted by Osceola County for FY2009 (\$4,867,305). If savings cannot be achieved by establishing a new southern operating base, Osceola County has committed to pay the entire funding amount. Staff hopes to have a subsequent analysis to present to the Board in the next sixty (60) days. If a savings can be identified and implemented in this fiscal year, the funding agreement could be adjusted accordingly.

#### **FISCAL IMPACT:**

The revised funding agreement is for \$5,075,993. This represents the original funding amount of \$4,975,993 approved by the Board in September 2008 plus the \$100,000 shortfall from the City of Kissimmee.

#### SERVICE FUNDING AGREEMENT BETWEEN OSCEOLA COUNTY AND LYNX FOR FISCAL YEAR 2008-2009

THIS AGREEMENT is made and entered into this \_\_\_\_ day of February, 2009, by and between OSCEOLA COUNTY, a charter county and a political subdivision of the State of Florida (hereinafter the "County"), and the CENTRAL FLORIDA REGIONAL TRANSPORTATION AUTHORITY, a body politic and corporate created pursuant to Part II, Chapter 343, Florida Statutes, (hereinafter "LYNX").

#### WITNESSETH

WHEREAS, Part II, Chapter 163, Florida Statutes (the "Local Government Comprehensive Planning and Land Development Regulation Act"), provides <u>inter alia</u> that specific public facilities and services must be available concurrently with the impacts of development; and

WHEREAS, the County recognizes the need to provide public transit services in an efficient manner and acknowledges the benefits of increased ridership on the regional public transit system; and

WHEREAS, increasing traffic congestion and continued population growth require an efficient and convenient public transit service; and

WHEREAS, an efficient and convenient public transit service offers a viable alternative to private automobile travel; and

WHEREAS, LYNX desires to provide public transit services within the County, and

WHEREAS, the County desires to provide LYNX with funding to support the operation of the public transportation service within the County; and

WHEREAS, at its meeting on September 24, 2008, the Osceola County Commission approved a budget allocation by which the County would provide to LYNX funding in the amount of \$4,867,305 (the "Approved County Funding") for LYNX to provide public transit services within the County; and

WHEREAS, on October 23, 2008, the Board of Directors of LYNX approved an arrangement for funding by the County for LYNX in the amount of \$4,975,993 (the "Approved LYNX Funding"); and

WHEREAS, the City of Kissimmee (the "City") is located within Osceola County, and LYNX has a separate funding arrangement with the City for transit services located within the City. In that regard:

- (a) LYNX originally approved funding from the City in the amount of \$220,000 at its meeting held September 25, 2008.
- (b) At its Board meeting held on January 22, 2009, the LYNX Board approved a revised funding agreement from the City in the amount of \$120,000 with the understanding that the County would "pick up" said difference or shortfall of \$100,000 in funding for LYNX; and

WHEREAS, taking into account the City funding shortfall of \$100,000, the funding then expected by LYNX from the County would be the sum of \$4,975,993 (i.e., the Approved LYNX Funding) plus the City funding shortfall (i.e., the \$100,000) for a total amount of \$5,075,993; and

WHEREAS, the difference between the LYNX requested funding of \$5,075,993 and the County approved funding of \$4,867,305 is \$208,688 (the "Funding Shortfall"); and

WHEREAS, LYNX and the County have held meetings between themselves regarding the provision of services by LYNX to see if there is any operating efficiencies that could be achieved with respect to the transit services provided by LYNX in Osceola County such as, for example, if there is placed in Osceola County an operations facility for utilization by LYNX would that facility eliminate any "deadhead time" on buses running back and forth between the LYNX Bus Operation Base in Orange County and the actual bus routes located in the County or through routing efficiencies such as "interlining".

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements hereinafter contained and other good and valuable consideration, the County and LYNX agree as follows:

- 1. <u>RECITALS.</u> The County and LYNX hereby declare that the recitals set forth above are true and correct and are incorporated herein and made a part of this Agreement.
- 2. <u>LYNX SERVICE AND REPORTING REQUIREMENTS.</u> In consideration of the funding provided by the County LYNX agrees to provide the services and reports specified in this agreement.
- 2.01 <u>SERVICE REQUIREMENTS.</u> Each service is associated with an allocation of the total amount of money to be paid by the County to LYNX under this agreement as indicated in Paragraph 3 a. The intent of the parties is that LYNX will provide at least the amount of service associated with each budget allocation associated with the specific service. The parties may shift dollars from one type of service (link) to another in order to balance the amount of money paid under this agreement with the services provided. Periodically the level of services shall be reconciled with the amount of money allocated to the services. At any time that the balance of the money remaining to be paid is projected to be significantly more or less than the amount required to pay for the balance of the remaining services, the parties shall meet and agree to an adjustment to the level of service to bring the budget allocations closer to the actual requirements. Such adjustments to the levels of service shall be documented in writing, however, need not be the subject of an amendment to this agreement. In no event shall the

County be obligated to pay any additional money in the absence of a written amendment to this agreement.

- 2.02 <u>REPORTING REQUIREMENTS.</u> Beginning on April 1, 2009 and on a quarterly basis thereafter, LYNX shall provide the County a written performance report reflecting the operations of the prior quarter (collectively referred to as "Performance Measures"). Each quarterly report will include the following items:
  - a. A route map, and schedule for each route operated in the County.
  - b. The actual aggregate ridership by transportation mode (Fixed Route bus, Lymmo, ACCESS LYNX, Van Plan and special shuttles) in the form of the official LYNX Monthly Ridership Reports.
  - c. Operational Service Characteristics Report for current services contemporaneous updates.
  - d. A comparison of actual revenue and expenditures to budgeted revenues and expenditures with explanations for variances that exceed Fifty Thousand Dollars (\$50,000).
  - e. LYNX Route Performance report which reports and ranks each route monthly based on the following:
    - \* Subsidy per passenger trip
    - \* Passengers per trip
    - \* Passengers per revenue hour
    - \* Passengers per revenue mile
    - \* Percent farebox return (percent of operating cost recovered through farebox)
  - f. Current and contemporaneous versions of the LYNX Regional Model. (This subsection (f) is not applicable for the current fiscal year funding."
  - g. Scheduled and actual Revenue Miles
  - h. Scheduled and actual Revenue Hours
  - i. Schedule of unanticipated extraordinary expenses for the prior quarter
  - j. Changes to authorized staffing
  - k. Any other information the County reasonably requests
  - 1. An historical record describing route changes including, but not limited to:
    - i. Addition of Route(s)
    - ii. Elimination of Route(s)
    - iii. Combination of Routes
    - iv. Addition of Evening Service
    - v. Addition of Weekend Service
    - vi. Other Route Scheduling Changes
    - vii. Running Time Adjustments

Quarterly reporting periods shall end on December 31, March 31, June 30, and September 30, and said reports shall be submitted to the County's Transportation Planning Department after the end of each quarter.

On an annual basis, within thirty days of receipt, LYNX shall provide the County with a copy of all external audits, a copy of the Comprehensive Annual Financial Report, which shall include the Report on Internal Controls, Report on Compliance with Laws and Regulations, and a copy of the management letter.

#### 3. FISCAL YEAR 2008-2009 FUNDING

a. The County agrees to appropriate \$4,867,305 to LYNX for Fiscal Year 2008-2009 itemized in Exhibit "A".

The funding is to be utilized by LYNX to provide public transit services in accordance with this Agreement. Such funds appropriated in the County's FY 2008-2009 Budget shall be paid in twelve (12) equal monthly installments of \$405,609 each which shall be due and payable on the first of each month. The first such payment shall be made no sooner than October 1, 2008, but recognizing that this Agreement is executed after said date, effective within ten (10) days after the date this Agreement is executed by both the County and LYNX, the County shall pay to LYNX all monthly payments (without interest) due for the months of October, 2008 to and including the month for which this Agreement is effective. Thereafter, the County will pay to LYNX the continuing monthly installment on the first day of each and every month.

- b. LYNX agrees to utilize the funds received from the County in accordance with the terms of this Agreement and to take all reasonable and necessary actions in a timely manner to initiate, implement, and operate the Public Transportation services in accordance with the terms of this Agreement. LYNX further agrees to demonstrate such initiation, implementation, and completion of such improvements by submitting reports to the County as defined in Section 2 of this Agreement.
- 4. <u>FUNDING FOR SHORTFALL OF \$208,688</u>. In regard to the Funding Shortfall, the parties agree as follows:
  - a. The County and LYNX will meet to study and review whether there are savings, if any, available in the event there is placed in Osceola County an operation base to service among other routes those routes in Osceola County or through operating efficiencies such as interlining of routes.
  - b. If it is reasonably determined that no savings are possible, then the County agrees to pay to LYNX on September 30, 2009 the Funding Shortfall.
  - c. If it is reasonably determined that said savings are possible with the establishment of a facility in Osceola County, then the parties will further discuss the location, cost and other matters associated with said facility.

- The parties will further determine whether there are any "net savings" available to the County as set forth below.
- d. If it is determined that there is no savings available, then the County will need to determine whether or not it wishes to pay the Funding Shortfall by June 1, 2009. If the County elects not to pay the Funding Shortfall, then LYNX and the County will work to reduce service in the County in an amount equal to said Funding Shortfall, unless otherwise agreed between the County and LYNX. For example, the County and LYNX may mutually agree to provide for the payment of said Funding Shortfall by the County in the subsequent fiscal year.
- e. For the purposes of determining any net savings that may result from an operation base in Osceola County, the parties will utilize the regional model recognizing that the cost will be the cost associated with the entire LYNX System and its funding partners and the savings will be savings that will be attributed to the entire system. It is only the "net savings" that would be recognized to the County based upon its share of the funding formula that will be considered for the purposes of this Agreement or the elimination of service hours attributed to deadhead hours.
- 5. <u>EFFECTIVE DATE.</u> The effective date of this Agreement is October 1, 2008. The term of this Agreement is one (1) year from its effective date.
- 6. <u>INTERPRETATION.</u> The headings contained in this Agreement are for reference purposes only and will not affect in any way the meaning or interpretation of this Agreement.
- 7. <u>NEGOTIATIONS</u>. The parties to this Agreement acknowledge that all terms of this Agreement were negotiated at arms length and that this Agreement and all documents executed in connection herewith were prepared and executed without undue influence exerted by any party or on any party. Further, this Agreement was drafted jointly by all parties, and no parties are entitled to the benefit of any rules of construction with respect to the interpretation of any terms, conditions, or provisions of this Agreement in favor of or against any person or party who drafted this Agreement.

#### 8. MISCELLANEOUS.

- a. This Agreement constitutes the entire Agreement between the parties with respect to the specific matters contained herein and supercedes all previous discussions, understandings, and agreements. Amendments to or waivers of the provisions herein shall be made by the parties in writing. No other agreements, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind either party hereto.
- b. If any sentence, phrase, paragraph, provision or portion of this Agreement is for any reason held invalid or constitutional by any court of competent jurisdiction, such portion shall be deemed an independent provision and such holding shall not affect the validity of the remaining portions hereto.

- c. The parties acknowledge that they have freely and voluntarily entered into this Agreement and that each party has been given the opportunity to receive the advice of independent legal counsel for all negotiations in connection with this Agreement.
- d. In any action or proceeding between the parties arising out of this Agreement, the prevailing party in such action or proceeding shall be entitled to recover all costs of such action or proceeding incurred by it, including reasonable attorneys' fees, at trial and on appeal.
- e. Time shall be of the essence of this Agreement.

#### 9. CONTROLLING LAWS.

- a. This Agreement and the provisions contained herein shall be construed, controlled, and interpreted according to the laws of the State of Florida, and all duly adopted ordinances, regulations and policies of the County now in effect and those hereinafter adopted.
- b. The location for settlement of any claims, controversies, or disputes, arising out of or relating to any part of this Agreement, or any breach hereof, shall be Osceola County, Florida.
- f. The parties to this Agreement agree to comply with all applicable federal, state, and local laws, ordinances, rules and regulations pertaining to the actions contemplated by this Agreement.
- 10. <u>BINDING NATURE OF AGREEMENT.</u> This Agreement shall be binding only between the County and LYNX, and inure to the benefit of the successors or assigns of the parties.
- 11. <u>NOTICES.</u> All notices, consents, approvals, waivers, and deletions which any party shall be required or shall desire to make or give under this Agreement shall be in writing and shall be sufficient only when mailed by certified mail, first class postage affixed, addressed as follows:

- 12. <u>RECORD KEEPING PROCEDURES</u>. LYNX shall keep and maintain accurate records of all services rendered in the performance of this Agreement and shall keep such records open to inspection by the County at reasonable hours during the entire term of this Agreement, plus three (3) years after expiration or termination of this Agreement. If any litigation, claim or audit is commenced prior to the expiration of the three (3) year period and extends beyond such period, the records shall be maintained until all litigation, including appeals, claims or audits have been concluded or resolved. Any person authorized by the County shall have access to and the right to examine any of the records.
- 13. <u>FILING OF AGREEMENT</u>. This Agreement shall be filed with the Clerk of the Circuit Court of Osceola County, Florida, or such other public official responsible under general or special law for the public records of Osceola County, Florida, in accordance with Section 163.01, Florida Statutes.
- 14. <u>SOVEREIGN IMMUNITY.</u> The parties are aware and understand that each of the parties hereto is a governmental agency entitled to the benefits of sovereign immunity. The parties agree that the County does not operate any of the transit services provided by LYNX, is not responsible for the purchase or maintenance of the equipment operated by LYNX, does not employ, train or otherwise deal with any employees of LYNX and has no control over the operations of LYNX except as may be stated herein and is therefore not liable for the negligence if any of LYNX. LYNX shall, within the limits of sovereign immunity, be liable for all claims for personal injury, including death, and property damage caused by the operation of LYNX' public transportation system, including all claims based upon the negligence or intentional acts of any LYNX employee, officer, director, contractor or other person, firm or corporation for whom LYNX may be legally responsible. Nothing contained herein shall constitute any waiver of any provisions of sovereign immunity by either party hereto.

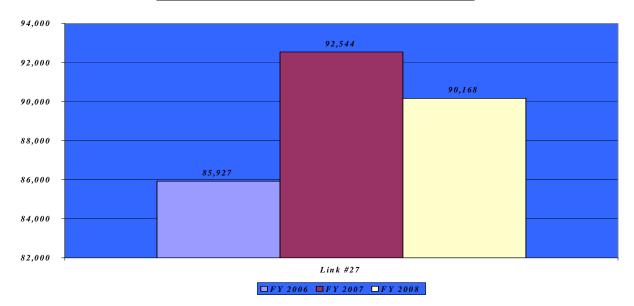

LINK 27 RIDERSHIP FOR FY 2006, 2007 & 2008

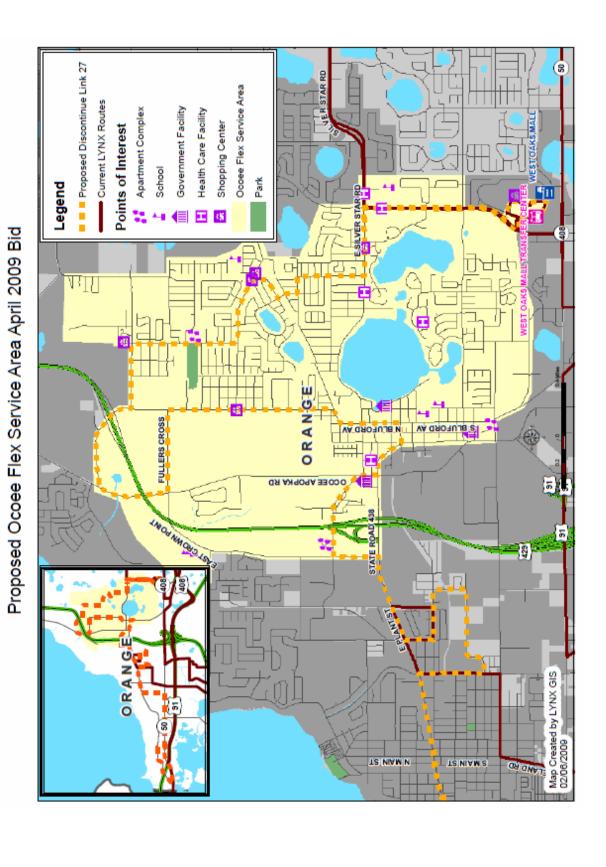

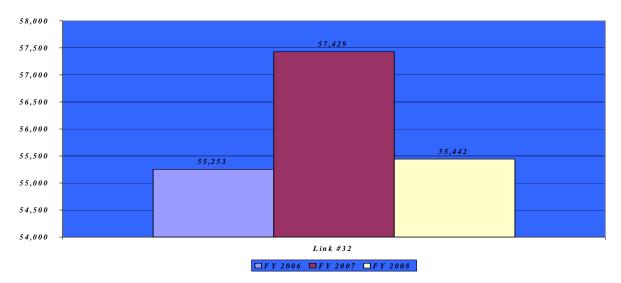

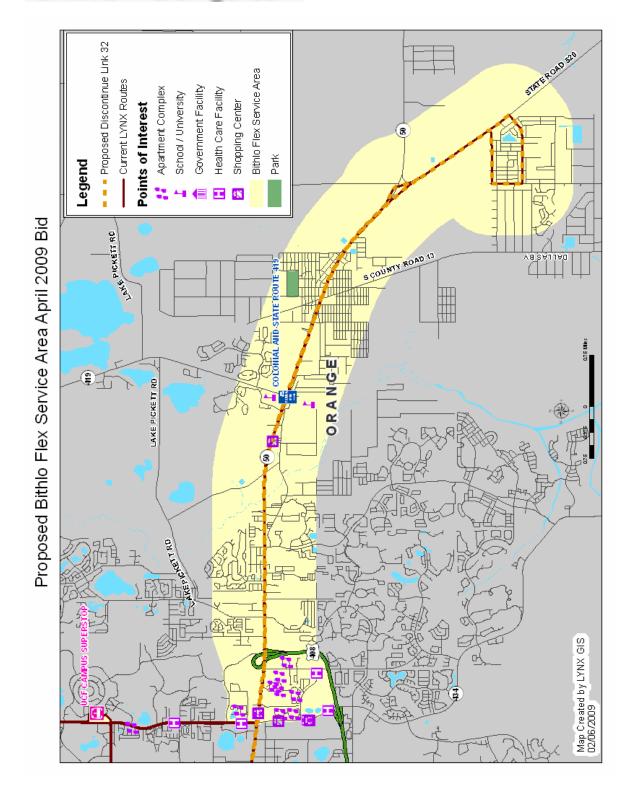

On Thursday, February 12, 2009, LYNX staff briefed the Local Coordinating Board (LCB) and requested approval of a proposed Transportation Disadvantaged (TD) fare increase.

The TD LCB oversees the TD Program of each Community Transportation Coordinator (CTC) throughout the State. As such, fares and policies related to each TD program are set by the LCB. Members of the LCB consist of representatives of human services agencies, disabled and disadvantaged customers, and a representative of each County Commission for Orange, Osceola, and Seminole counties.

The FY 08 TD grant was \$2,896,653. Of this amount, LYNX was required to have a 10% match of local funds or revenue in the amount of \$289,665. LYNX only collected \$211,166 (7.29%), for a shortfall of \$78,499, which was part of the paratransit loss for FY 08. The following is the proposed fare increase for FY 09; recommended to address future losses.

Distance	<b>Current Fares</b>	<b>Proposed Fares</b>
0 to 4.99 Miles	\$2.50	\$3.50
5 to 9.99 Miles	\$3.50	\$5.50
10+ Miles	\$4.50	\$7.50



The FY 09 TD grant is \$2,973,015. Of this amount, LYNX is required to collect \$297,301 as match. During the first quarter of FY 09 LYNX has only collected \$60,176 (6.79%). Given this trend, LYNX anticipates a loss of approximately \$113,844 for FY 09.

The LCB made the decision to keep fares at the current level and instead, recommend a review and possible revision of current policies to decrease the fare collection issue. If 100% of the fares were collected for FY 09, it is likely that we would meet the 10% match requirement. The LCB also asked that the LYNX Board consider using fuel savings, reserves, etc., to cover the gap in fares until the collection issue is resolved.

Staff will brief the Board on the full LCB discussion at the Board meeting.

Please find attached the monthly financial report for the one month ending October 31, 2008. LYNX' Statement of Revenues, Expenses, and Changes in Net Assets (Operating Statement) for the one month ending October 31, 2008 reflect total revenue earned in the amount of \$9,189,784 and total expenses incurred in the amount of \$8,634,712 resulting in a net operating profit of \$555.072.

- Fixed route and Vanpool services resulted in an operating profit of \$618,334 for the first month of the fiscal year.
- Paratransit services resulted in an operating loss of \$(63,262) for the first month of the fiscal year.

#### **Fixed Route Operations:**

The year-to-date Operating Revenues are slightly lower than the budget at 94%. Customer fares are at 96% of the budgeted amount year-to-date resulting in 4% below the budget amount for the month of October.

Although we have experienced some decreases in fuel prices, the cost of fuel is over budget by approximately 8% for the first month of the fiscal year. On the positive side, fixed route operating expenses for salaries, wages, and fringe are under budget due to various vacancies and service changes implemented in August 2008. In addition, expenses related to utilities are less than budgeted. Casualty and liability insurance expenses are significantly under budget due to the timing of the settlement of several outstanding claims anticipated for the year.



#### **Paratransit Operations:**

The operating loss from Paratransit operations is a result of higher than anticipated purchased transportation costs year-to-date. This is directly related to the increase in paratransit trip levels.

We will monitor the trip levels in order to ensure consistency with planned operating expenses and make appropriate adjustments, as needed. In addition, staff continues to oversee the operations of this program to ensure that the provider is in compliance with the required service performance standards and other contractual obligations.

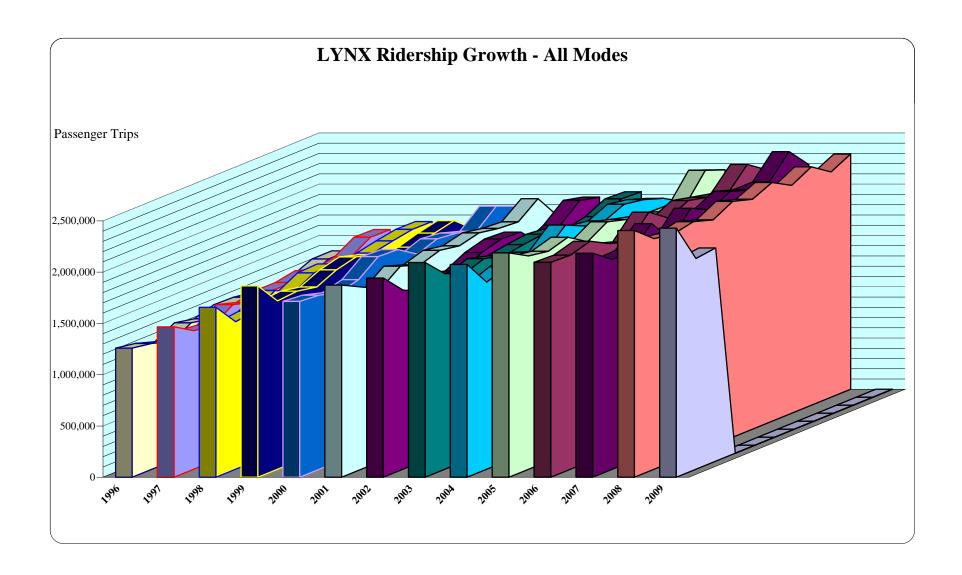

#### **Coordination Activities**

**Orange County** - Staff has coordinated with City of Winter Garden for the installation of trash cans along the LINK 442 route. In exchange for LYNX installing trash cans at 12 stops along the route, the city has agreed to pick up the trash.

LYNX has also finished coordination with the Jaycees to adopt 14 stops along 2 routes (the LINK 8 and the LINK 57). Similar to the City of Winter Garden, the Jaycees will pick up trash in the exchange for the installation of trash cans.

**Osceola County -** LYNX staff is coordinating with Wal-Mart located in Poinciana for the installation of a shelter at an existing bus bay. This shelter will help serve both the LINK 26 and the associated Flex-route service in the area.

**Seminole County -** LYNX has coordinated with the County and the City of Lake Mary for installation of a trash can along the LINK 45 on Lake Mary Boulevard.

#### **Geography Network**

The main page and the three web applications currently available on LYNX Geography Network had been loaded on a desktop 983 times between January 1 and January 29, 2009.

#### **GIS**

GIS staff is working on scheduled updates of the streets basemap for LYNX' service area. The compiled regional files will be distributed to the following GIS based applications – Trapeze FX, Trapeze PASS, and Passenger Trip Planner.

Under phase two of the Partners for Structures layer project, funded under the USGS Assistantship program, LYNX' GIS staff is working on compiling the data and creating models for data-conversion. The data and the models for Orlando Urbanized Area that falls in Lake County would be shared with County GIS management that committed to adopt and maintain the structure for future regional database updates.

GIS staff is working with Service Design and ACCESS LYNX staff on defining the geography of the service area for LYNX' new Flex service.

# Federal Job Access and Reverse Commute (JARC) Program and the New Freedom Program (NFP) - Coordinated Transportation Planning Meeting

Following up on recent coordinated transportation meetings, LYNX Planning and Development staff has been working with a number of human services agencies who have expressed interest to develop projects responsive to transportation needs and gaps identified. Many of these agencies are anticipating funding shortfalls from various sources, from various federal, state, and local government programs as well as from charitable sources. New opportunities for ensuring dependable transportation options are being sought to ensure individuals served by these agencies are able to access the many programs and services important to promoting self-sufficiency. Types of projects being considered are vanpool programs, expansion of client transportation services provided by some of the agencies, as well as voucher arrangements that will allow more individuals to access social service programs.

#### **MORE TMCC**

There were eight sites including Central Florida, that were chosen by the United We Ride (UWR)/Mobility Services for All Americans (MSA) joint initiative to develop plans for regional coordination of Human Services sponsored transportation services. This Phase I effort was to develop plans for various types of agencies to service as models for how to develop a coordinated transportation system.

Three agencies were chose from the eight Phase I projects to proceed to Phase II, deployment of the plan developed in Phase I. The evaluation and decision by the Federal team did not focus on the best overall plan but on plans that had the most potential for replication at other similar sites throughout the United States. Teams from Aiken, S.C., Cherry Hill, N.J., and Paducah, K.Y. were chosen for Phase II funding of the deployment of their design. The team from Atlanta, G.A. has chosen to drop out of the project.

The remaining four teams, including Central Florida, have been requested to submit a proposal to the Federal Transit Administration to utilize the remaining funding to provide support to the three Phase II participants and to advance a small portion of our design from Phase I. We anticipate receiving \$100,000 through these available funds.

Staff will submit a proposal related to the coordination of Human Services transportation provision in the Central Florida area to the Federal Transit Administration, including the required provision to provide support to the three Phase II projects. Further information on this proposal will be provided at the March 2009 meeting of the LYNX Board of Directors.

#### **Shelters and Amenities**

**Orange County** – LYNX' staff is still working through the permitting process for approximately 12 shelters on Oakridge Road and is currently permitting another 7 shelters on Silver Star Road, as well as the 2 shelters in Tangelo Park and the 6 shelters at the Florida Mall.

**City of Orlando** – LYNX' staff received permits and is also in the process of installing 8 shelters at the following locations: 6 on Oakridge Road, 1 on Michigan Street (in front of the Boston Market) and one on Osceola Avenue downtown (near a senior residential tower).

**City of Sanford** – LYNX' staff is currently working with the City of Sanford CRA and started the refurbishment of 4 existing shelters. In addition, LYNX is currently having an existing shelter refurbished for re-installation at an existing shelter pad at a Wal-Mart located on Rinehart Road in Sanford.

**Seminole County -** LYNX staff has received the go ahead from the Seminole County Redevelopment Planning Agency for installation of shelters along the US 17/92 corridor. LYNX staff has also began coordinating with the associated municipal partners within the CRA and also with the City of Longwood to begin the process of ordering the shelters and permitting. It is anticipated that by the end of the fiscal year to have a minimum of 23 shelters installed along the corridor.

**Winter Park** - LYNX has completed negotiations with the City of Winter Park and has received Board approval of the Transit Interlocal Agreement with City of Winter Park. There are 6 shelters currently on order from the manufacturer with an anticipated installation date of March/April 2009.

#### Developments of Regional Impact (DRI's)/Roadway Projects

LYNX staff reviewed and/or commented on the following projects, and attended meetings related to these projects.

#### **Rybolt Park**

- Project is located west of CR 419 and east of UCF in eastern Orange County.
- LYNX' staff has previously attended a pre-application meeting for this project. Subsquently, LYNX' presence was requested at a transportation meeting specific to the project prior to the submittal of the application to the Regional Planning Council. One of the primary purposes of this meeting was to discuss possible solutions for the inclusion of transit in the plan submitted to the Regional Planning Council. LYNX' staff position is any extension of service under the current funding model will have to be developer funded and that this also must be front loaded into the project.



#### **Center of Commerce Monitoring and Modeling Study**

- Project is located in the City of Orlando and is north of Silver Star Road off of Mercy Drive.
- Project is currently served by the LINK 25.
- Project at certain thresholds will be required to provide traffic mitigation to off-set the impact of traffic on the surrounding area. This normally involves expensive modifications to or expansion of the local roadways. LYNX has suggested to the developer that contributing to improving service in the area, such as improving headways, may be an alternate means of providing this mitigation. Project staff have noted this and will keep LYNX staff informed at what point the agency may need to enter into discussions for assisting with traffic mitigation.

#### Camino Reale DRI First Comment Review for ADA

- Project is located in eastern Orange County in the Innovation Way Study area south of SR 528
- LYNX' staff requested the developer to address how transit will be incorporated into the first phase of the project.
- LYNX' staff asked for clarification on the project's transit connectivity with the LYNX system and how the project is partnering with other projects within the Innovation Way Corridor.

#### **Road Projects**

Staff provided comments and/or was involved in the regional review process for the following road projects:

#### **Orange County**

Widening of Hoffner Road from Conway to Lee Vista – LYNX' staff has provided additional comments to the consultant and Florida Department of Transportation (FDOT). LYNX' staff has requested ADA pads for approximately 6 bus stops and shelter pads.

Bridge replacement CR 535/Vineland Road – LYNX' staff is coordinating with the contractor for detours associated with this project. A permanent detour for at least 1 year will be in place for the LINK 442.

SR 50 Widening from Good Homes to Pine Hills Road – LYNX' staff is coordinating with the contractor with respect to shelter relocations and stop movements required as part of the road widening project.

President Obama signed HR 1, the American Recovery and Reinvestment Act, on February 17 in Denver. The final House vote was 246 to 183 - not one Republican voted for the final bill. In the Senate, the vote was 60 to 38 – exactly the number of votes needed to pass the bill. The same three moderate Republicans who voted for earlier versions of the bill voted in support – Senators Snowe and Collins of Maine and Specter of Pennsylvania. All other Republicans voted against the bill.

The economic recovery legislation provides \$8.4 billion for investments in public transportation projects. Of the \$8.4 billion provided for public transit, \$6.9 billion will be distributed to public transit systems through the Federal Transit Administration's formula program that is already in place. The remaining \$1.5 billion will be available as grants for new major projects and modernizing the nation's urban rail systems.

The legislation also includes for the first time, a significant investment of \$9.3 billion for intercity passenger rail, including \$8 billion for high speed rail corridors and \$1.3 billion for Amtrak. Additionally, there is \$1.5 billion for a new, intermodal discretionary program that can be used for public transportation, highways, bridges, freight rail, and ports. Separately, an additional \$150 million for rail and transit security grants is provided to help make our public transportation systems more secure.

Congress also included tax incentives to encourage transit commute benefits at the same level as parking benefits, for the first time, has made the transit commute benefit equal to the parking benefit, which is currently \$230 per month. This action will provide a tax-free way for employers to encourage their employees to use energy-efficient, fuel-saving public transportation.

The total recovery package is \$789 billion with approximately \$48.1 billion of that in new spending for transportation programs.

#### Transit –

- \$8.4 billion total funding
- Includes \$6.8 billion for the capital formula program, \$750 million for the Rail Mod program, \$750 million for the New Starts/Small Starts program and \$100M for discretionary capital grants to reduce energy consumption or green house gas emissions.
- The additional New Starts funding will produce about \$1.5 billion in additional Contingent Commitment Authority (CCA) that FTA can use to sign additional Full Funding Grant Agreements (FFGAs).
- The first 50% of the capital and Rail Mod funds must be "obligated" within 180 days. Any funds not used will be redistributed to other recipients. All remaining funds must be obligated within one year of the date of enactment. Funds remain available until 9/30/2010.
- The New Starts funds will be allocated at the discretion of the US DOT Secretary with priority given to those projects already under construction (have an FFGA) and those who can obligate the funds within 150 days. No "use it or lose it" requirement. Funding remains available through 9/30/2010. Current match ratio is retained.

### Passenger Rail -

- <u>Amtrak</u> \$850 million for Amtrak capital improvements and \$450 million for capital security grants
- <u>High Speed Rail</u> A total of \$8 billion is provided for intercity passenger rail and the high speed rail corridor program. The Secretary must submit a funding plan to Congress within 60 days and issue grant criteria within 120 days of enactment. 100% Federal share.

#### Reports and Requirements -

- Governors must certify within 30 days of enactment that the state will maintain its efforts on transportation projects in other words not simply substitute federal funds for existing state funds. States failing to maintain their state efforts will be prohibited from participating in the FY'2011 redistribution of federal highway funds.
- State and local governments must submit 90-day, 180-day 1-year, 2-year and 3-year reports showing information such as the number of contracts awarded and completed and jobs created and sustained.



Under any circumstances, LYNX will receive money from the Stimulus package. The legislation includes some transit money to be distributed under the formula grant program. Beyond that, we will work to obtain available discretionary monies.

Congress will soon turn its attention to completing the Fiscal Year 2009 Appropriations bills. It is probable that the nine unfinished Appropriations bills will be combined into one Omnibus Appropriations bill. Congress returns to session the week of February 23. The existing Continuing Resolution expires on March 6. The Congress hopes to pass the Omnibus bill before that date.

As reported previously, the unfinished Transportation Appropriations bill included two discretionary appropriations -- \$3 million for LYNX buses and \$8 million for expansion of the LYMMO system. It is expected that these appropriations will be included in the Omnibus bill.
